LEGIBLE SIGNATURE**WORK PERMIT VISA**

- The Work Permit Visa must be used within sixty days of the date it is issued and allows the holder multiple entries and stays until the end of the work contract, and the employer must notify the competent authority of any change in the duration of the contract for the purposes of the law.

- The Work Permit Visa only allows its holder to carry out the professional activity that justified its granting and entitles them to dedicate themselves exclusively to the service of the employer who applied for it.

- The Work Permit Visa does not allow its holder to take up residence in national territory.

Nº 2.3 e 5, of article 51º of the Law 2/07 of 31 August**TEMPORARY PERMIT VISA**

- The Temporary Permit Visa must be used within sixty days of being issued and entitle the holder to multiple entries and stays of up to three hundred and sixty-five days, extendable successively until the end of the reason for which they were issued.

ATT: The validity of the Temporary Permit Visa granted must not exceed the length of stay granted to the holder of the entry visa that gave rise to its issue.

- The Temporary Permit Visa does not entitle its holder to take up residence in national territory.

Nº 2.3 e 5, of article 51º of the Law 2/07 of 31 August**RESIDENCE PERMIT VISA**

- The Residence Permit Visa permit must be used within sixty days of its issue and gives its holder the right to remain in national territory for a period of one hundred and twenty days, extendable for equal periods, until the final decision on the residence permit application.

- The Residence Permit Visa permit entitles its holder to engage in paid professional activity.

Nº 2.3 e 5, of article 51º of the Law 2/07 of 31 August**STUDY PERMIT VISA**

The Study Permit Visa must be used within sixty days of the date it is issued and allows the holder to stay for one year, extendable for the same period until the end of their studies, and is valid for multiple entries.

The Study Permit Visa does not allow the holder to take up residence in national territory, nor to engage in paid work, except for training-related internships.
